Part A: Pupil premium strategy plan

Statement of intent

Kingsland CE Academy is a Church of England faith School and is part of St. Bart's Multi-Academy Trust. It is 2 form entry school.

The school is located in an area of high deprivation and therefore as a result a high percentage of our children are eligible for pupil premium.

The staff Kingsland C.E. Academy, have high aspirations and ambitions for our children and we believe that no child should be left behind. We are determined to ensure that our children are given every chance to realise their full potential.

In order to ensure maximum progress:

ALL teaching staff and support staff are involved in the analysis of data and identification of pupils.

ALL staff are aware of who pupil premium and vulnerable children are.

All pupil premium children benefit from the funding, not just those who are underachieving.

Underachievement at all levels is targeted.

Children's individual needs are considered carefully.

Staff believe in ALL children.

Staff adopt a 'solution-focused' approach to overcoming barriers.

Challenges

1	<p><i>Observations, discussions and assessments show that children at Kingsland have lower literacy skills than the national average.</i></p> <p><i>In 2019-2020, 58% % of disadvantaged pupils achieved the expected standard in reading and 66% in writing, compared to 73% of nationally non disadvantaged for reading and 78% for writing. This gap has grown due to Covid and lockdowns.</i></p>
2	<p><i>Observations, discussions and assessments show that children at Kingsland have lower numeracy skills than the national average.</i></p> <p><i>In 2019-2020, 63% of disadvantaged pupils achieved the expected standard, compared to 79% of nationally non disadvantaged. This gap has grown due to Covid and lockdowns.</i></p>
3	<p>Observations and discussions have shown that due to experiences in their past some disadvantaged families, can be reluctant to access the school and that others would like to help their children more at home, but would like more support with this.</p>
4	<p><i>Observations, discussions and assessments show that across the school many pupils show underdeveloped oral language and vocabulary skills.</i></p>

5	Our observations and discussions have shown that some disadvantaged children are not aware of opportunities that available to them after they leave school and can lack aspirations to achieve well.
6	Some disadvantaged pupils and families need additional support to ensure that they are arriving punctually and regularly. Data on attendance shows us that attendance for disadvantaged children 2018-2019 was 95.5%. This is lower than our aim for 97%. Covid has severely impacted on our attendance data.

Part B: Review of outcomes in the previous academic year

Pupil premium strategy outcomes

This details the impact that our pupil premium activity had on pupils in the 2021 to 2022 academic year.

The use of RWI, Power Maths, Pathways to Read and Pathways to Write have had a positive impact on results in KS1 with results improving for PP children in reading, writing, maths and combined since the SATs were last taken in 2019-2020.

We have not yet seen an impact on the results in KS2, but in school assessments, show that these schemes are also creating an increase in attainment in other year groups.

As a school we have identified that writing remains a difficulty for many in KS2 and therefore we are involved in a trial of Pathways to Progress to support and improve writing in Years 3 and 4. There will be targeted HLTA support in Year 5 and 6 to support the improvement of writing in Years 5 and 6.

Covid continued to have a significant impact on attendance last year with average attendance for PP children at 88% for the academic year. We are continuing to work with VIP Education who are now able to support more with house calls etc due to the removal of covid restrictions.

A teaching and learning practitioner was employed to deliver small group teaching in Year 6 in order to raise standards. For reading 50% of the disadvantaged children in this target group made better than expected progress and achieved the expected standard at the end of Year 6. In maths 100% of the disadvantaged children in the group made better than expected progress and achieved the expected standard at the end of Year 6. The writing intervention was less successful with only 17% of the pupil premium children in the group making accelerated progress and therefore achieving the expected standard at the end of the year.

CPOMs has continued to be used successfully to safeguard children. Approximately 76% of all reports made in the last academic year were for disadvantaged pupils.
